Section A – Information for GP Trainees

Changes to your training number (NTN or DTN)

The GMC have asked all UK deaneries and HEE Local Offices to make changes to the format of NTN and DRN. The reason for the change is to enable more accurate recording of training, particularly regarding dual training and sub-specialty training where this applies. The change is to the format of the training numbers only and does not alter anything else in relation to your training agreement. Health Education England working across London, Kent, Surrey and Sussex will be issuing these new training numbers in the next few months. Further communications will be sent prior to the new numbers being issued.

Please note: if you will CCT before 1 January 2019, you have not been issued with a new training number, your 'old' number will be maintained.

Please note: if you are a new trainee in the region from the 1 August 2018, you may already have been issued a temporary NTN/DRN. However, the training number may need to be updated. The Colleges and Faculties are aware of the situation and will know that some of you may not yet have been issued with a training number due to this piece of work with the GMC.

Please note for GP trainees the RCGP will be notified of all changes to NTN/DRNs, they will update their internal records and your eportfolio record. There is no action needed on your part.

[Darzi fellowship opportunities](#)

Following its great success over the past two years, the Darzi Fellowships in Clinical Leadership is returning to Kent, Surrey and Sussex.

The initiative has a strong history in London, where it has been running for more than ten years. In 2017 we were thrilled to become the first region outside of the capital to recruit Darzi Fellows, with a second tranche recruited in 2018.

So far more than 50 Fellows have made significant impact across the region, working on a range of projects covering everything from end of life care to mental health, social prescribing and frailty.

We're now set to recruit the third group of Fellows to this amazing experience, which is aimed at those at the start of their leadership journey (**AND THIS INCLUDES GP TRAINEES IN ST2 OR 3**). Darzi Fellows come from multi-professional clinical backgrounds, including doctors, nurses and midwives, allied health professionals, paramedics, dentists, healthcare scientists and pharmacists.

The programme is full-time for one year, with Fellows undertaking one main project for their sponsor. They also complete a leadership development programme (PG Cert) at London South Bank University, which informs their ability to lead on their project.

Over the past ten years Darzi Fellows have led major service improvements, implemented numerous safety and quality initiatives, and achieved substantial financial savings for trusts. Alongside patient benefits, the prestigious Darzi Fellowship programme has been shown to have a huge impact on Fellows and their sponsoring organisation.
